Point of diversion and place of use of a portion

of water heretofore appropriated under 19330

1. The source of water is Underground (Name of stream, lake or other source.)

2. The amount of water to be changed 2.2 c.f.s. (1/2 of 4.4 c.f.s. previously (Second feet, acre feet.) Appropriated

3. The water to be used for Irrigation (If for stock state number and kind of animals.)

4. The water heretofore used for Irrigation (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point SW 1/4 NE 1/4 Sec. 33, T. 3 S., R. 55 E.,

M.D.M. (J.C.P.) or at a point from which the NE Cor. of said Sec. 33 (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

bears N. 44° 18' E. (J.C.P.) a distance of 1900 ft. SW 1/4 NW 1/4 Sec. 33, T. 3 S., R. 55 E., (J.C.P) M.D.B.&M., or

6. The existing point of diversion is located within/at a point from which the W 1/4 Cor. of said Sec. 33 bears S. 33° 36' W., a distance of 544 ft. The tie shown under Permit No. 19330 was "At a point from which the NE corner of Sec. 36, T. 3 S., R. 55 E.,

M.D.B.&M., bears N. 83° 47' E., a distance of 21,114 feet". The tie was made prior to the dependent re-survey of 1964. (If point of diversion is not changed, do not answer.)

7. Proposed place of use NE 1/4 (J.C.P.) Sec. 33, T. 3 S., R. 55 E., M.D.M. (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.)

8. Existing place of use N 1/2 Sec. 33, T. 3 S., R. 55 E., M.D.M. (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

9. Use will be from Jan. 1 (Month) to Dec. 31 (Month) of each year.

10. Use has been from Jan. 1 (Month) to Dec. 31 (Month) of each year.

Installation of well, pump and valley irrigation system

It is desired to change the pt. of diversion of 1/2 of the water to irrigate 1/2 of the land heretofore appropriated in order to change the system of irrigation from flooding to valley sprinkling system.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 19330 is issued subject to the terms and conditions imposed in said Permit 19330 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.2 cubic feet per second, but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before July 8, 1968

Proof of commencement of work shall be filed before August 8, 1968

Work must be prosecuted with reasonable diligence and be completed on or before July 8, 1969

Proof of completion of work shall be filed before August 8, 1969

Application of water to beneficial use shall be made on or before July 8, 1971

Proof of the application of water to beneficial use shall be filed on or before August 8, 1971

Map in support of proof of beneficial use shall be filed on or before August 8, 1971

Commencement of work filed Aug 30, 1968

Completion of work filed Aug 16, 1969

Proof of beneficial use filed
