The applicant Naomi Beatrice Harper of Anton, County of Hockley

State of Texas, hereby makes application for permission to change the Point of Diversion

of water heretofore appropriated under Permit No. 21215

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Underground (Name of stream, lake or other source.)

2. The amount of water to be changed 5.4 second feet (Second feet, acre feet.)

3. The water to be used for Irrigation and Domestic (If for stock state number and kind of animals.)

4. The water heretofore used for Irrigation and Domestic (No change.) (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point SE 1/4 SE 1/4 Section 22, T. 19 N., R. 55 E., M.D.B. & M., or at a point from which the SW corner of said Section 22 bears S. 85° 17' W. a distance of 5030.00 feet. (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

6. The existing point of diversion is located within SW 1/4 SE 1/4 Section 22, T. 19 N., R. 55 E., M.D.B. & M. or at a point from which the NW corner of said Section 22 bears N. 43° 24' W. a distance of 5600.00 feet (If point of diversion is not changed, do not answer.)

7. Proposed place of use E 1/2 Section 22, T. 19 N., R. 55 E., M.D.B. & M. 320 acres. (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.) (No change.)

8. Existing place of use E 1/2 Section 22, T. 19 N., R. 55 E., M.D.B. & M. 320 acres. (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

9. Use will be from January 1st (Month) to December 31st (Month) of each year.

10. Use has been from January 1st (Month) to December 31st (Month) of each year.

11. Description of proposed works:

Drilled well, pump, pipelines and sprinklers

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 21215 is issued subject to the terms and conditions imposed in said Permit 21215 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before June 30, 1967

Proof of commencement of work shall be filed before July 30, 1967

Work must be prosecuted with reasonable diligence and be completed on or before June 30, 1967

Proof of completion of work shall be filed before July 30, 1967

Application of water to beneficial use shall be made on or before September 30, 1969

Proof of the application of water to beneficial use shall be filed on or before October 30, 1969

Map in support of proof of beneficial use shall be filed on or before October 30, 1969

Commencement of work filed AUG 23 1967

Completion of work filed AUG 23 1967

Proof of beneficial use filed
