State of Texas, hereby makes application for permission to change the Point of Diversion

of water heretofore appropriated under Permit No. 21712

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Underground Sources (Name of stream, lake or other source.)

2. The amount of water to be changed 5.4 c.f.s. (Second feet, acre feet.)

3. The water to be used for Irrigation & Domestic (If for stock state number and kind of animals.)

4. The water heretofore used for Irrigation & Domestic (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point In the NW 1/4 SE 1/4 Sec. 26, T. 9 N., R. 65 E., M.D.B.&M., or at a point from which the NE corner of said Sec. 26 bears N. 23° 48' 46" E., 3653.45 feet distant.

6. The existing point of diversion is located within The SE 1/4 NE 1/4 Sec. 26, T. 9 N., R. 65 E., M.D.B.&M., or at a point from which the NE corner of said Sec. 26, bears N. 29° 20' 39" E., 1839.90 feet distant.

7. Proposed place of use S 1/2 NW 1/4, SW 1/4 NE 1/4, N 1/2 SW 1/4 and NW 1/4 SE 1/4 Sec. 25, SE 1/4 NE 1/4 and NE 1/4 SE 1/4 Sec. 26, T. 9 N., R. 65 E., M.D.B.&M. - 320 Acres

8. Existing place of use S 1/2 NW 1/4, SW 1/4 NE 1/4, N 1/2 SW 1/4 and NW 1/4 SE 1/4 Sec. 25, SE 1/4 NE 1/4 and NE 1/4 SE 1/4 Sec. 26, T. 9 N., R. 65 E., M.D.B.&M. - 320 Acres

9. Use will be from January 1st to December 31st of each year.

10. Use has been from January 1st to December 31st of each year.

11. Description of proposed works.

It is proposed to drill, develop, case & equip an irrigation well for use as described hereon. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) (State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.)

12. Estimated cost of works \$15,000.00

13. Estimated time required to construct works 3 Years

14. Remarks This well is necessary to gain sufficient elevation at well to utilize irrigation plan as shown on supporting map.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 21712 is issued subject to the terms and conditions imposed in said Permit 21712 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before October 14, 1967
Proof of commencement of work shall be filed before November 14, 1967
Work must be prosecuted with reasonable diligence and be completed on or before October 14, 1968
Proof of completion of work shall be filed before November 14, 1968
Application of water to beneficial use shall be made on or before October 14, 1971
Proof of the application of water to beneficial use shall be filed on or before November 14, 1971
Map in support of proof of beneficial use shall be filed on or before November 14, 1971
