This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of the Truckee River as heretofore granted under Claim No. 587, (Permit 21005), Truckee River Final Decree is issued subject to the terms and conditions and Permit 21005 imposed in said decree/and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.375 cubic feet per second or 34.0 acre-feet annually.

Actual construction work shall begin on or before October 24, 1967

Proof of commencement of work shall be filed before November 24, 1967

Work must be prosecuted with reasonable diligence and be completed on or before October 24, 1968
