1. The source of water is Truckee River (Name of stream, lake or other source.)

2. The amount of water to be changed 5.575 c.f.s. not to exceed 901.0 ac. ft. annually (Second feet, acre feet.)

4. The water heretofore used for Municipal and Domestic (If for stock state number and kind of animals.)

The water is to be diverted at the following point in the SE 1/4 SE 1/4 of Section 10, T. 19N., R19E MDB&M at a point from which the SE corner of said Section 10 bears South 69°57'58" East 842.34 feet (Idlewild Pump Station) (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

6. The existing point of diversion is located within the SE 1/4 NE 1/4 Section 16 T19N R19E MDB&M at a point from which the NE corner of said Section 16 bears North 26°30' East a distance of 1702 feet (Reno Power Dam) (If point of diversion is not changed, do not answer.)

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of the Truckee River as heretofore granted under Claim 523, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and Permit 21024 and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.575 cubic feet per second, but not to exceed 901.0 acre-feet annually.

Actual construction work shall begin on or before December 16, 1967

Proof of commencement of work shall be filed before January 16, 1968

Work must be prosecuted with reasonable diligence and be completed on or before December 16, 1968

Proof of completion of work shall be filed before January 16, 1969

Application of water to beneficial use shall be made on or before December 16, 1969

Proof of the application of water to beneficial use shall be filed on or before January 16, 1970
