The applicant Sierra Pacific Power of 100 E. Moana Lane, Reno, County of Washoe State of Nevada hereby makes application for permission to change the point of diversion

of water heretofore appropriated under Permit # 21025 Certificate # Truckee River Decree Claim # 519 (Abbee Ditch) (Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Truckee River (Name of stream, lake or other source.)

2. The amount of water to be changed .425 c.f.s. not to exceed 67.0 ac. ft. annually (Second feet, acre feet.)

3. The water to be used for Municipal and Domestic (If for stock state number and kind of animals.)

4. The water heretofore used for Municipal and Domestic (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point in the SE 1/4 SE 1/4 of Section 10, T19N R19E MDB&M at a point from which the SE corner of said Section 10 bears South 69° 57'58" East 842.34 feet (Idlewild Pump Station) (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

6. The existing point of diversion is located within the SE 1/4 NE 1/4 Section 16 T19N R19E MDB&M at a point from which the NE corner of said Section 16 bears north 26°30' East a distance of 1702 feet (Reno Power Dam) (If point of diversion is not changed, do not answer.)

7. Proposed place of use (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.) Sections 31, 32 and 33, T20N R20E MDB&M Sections 4, 5, 6, 7, 8, & 9, T19N R20E MDB&M Sections 35 & 36, T20N R 19E MDB&M Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 16, 17, 20, 21, 22, 23, 24, 25, 26, 27, T19N R19E, MDB&M

8. Existing place of use (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.) Same as Question 7

9. Use will be from as decreed (Month) to (Month) of each year.

Water will be pumped from the Truckee River to the treatment plant near Idlewild

Park and thence to the distribution system serving the Reno-Sparks metropolitan area.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of the Truckee River as heretofore granted under Claim 519, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and Permit 21025 and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.425 cubic feet per second, but not to exceed 67.0 acre-feet annually.

Actual construction work shall begin on or before December 16, 1967

Proof of commencement of work shall be filed before January 16, 1968

Work must be prosecuted with reasonable diligence and be completed on or before December 16, 1968

Proof of completion of work shall be filed before January 16, 1969

Application of water to beneficial use shall be made on or before December 16, 1969

Proof of the application of water to beneficial use shall be filed on or before January 16, 1970
