The applicant Sierra Pacific Power Company of 100 E. Moana Lane, Reno, County of Washoe State of Nevada, hereby makes application for permission to change the point of diversion

of water heretofore appropriated under Permit #21026 Certificate # Truckee River Decree Claim #518 (Abbee Ditch)

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of the Truckee River as heretofore granted under Claim 518, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and Permit 21026 and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.50 cubic feet per second, but not to exceed 692.0 acre-feet annually.

Actual construction work shall begin on or before December 16, 1967. Proof of commencement of work shall be filed before January 16, 1968. Work must be prosecuted with reasonable diligence and be completed on or before December 16, 1968. Proof of completion of work shall be filed before January 16, 1969. Application of water to beneficial use shall be made on or before December 16, 1969. Proof of the application of water to beneficial use shall be filed on or before January 16, 1970. Map in support of proof of beneficial use shall be filed on or before
