11. Remarks Works of diversion consist of certain pipes and ditches which lead from the point of emmission of water from the Reno-Sparks Sewer Plant. Water is then conveyed from that point through a portion of the Steamboat Slough which is a natural waterway and drainage canal through the Truckee River and thence into Pyramid Lake. In Pyramid Lake the water will be used for fish and wild life propagation and domestic use. Applicants are the owners of a resort fronting on said lake and they, their agents and guests will make such uses. Also, such uses will be made of said waters by the general public.
