The applicant SIERRA PACIFIC POWER COMPANY of PO Box 2111, County of Washoe

State of Nevada, hereby makes application for permission to change the point of diversion, manner and place of use

of water heretofore appropriated under Claim #172 of the Truckee River Decree being the decree entered by the District Court of the United States for Nevada in the case of U. S. vs Orr Water Ditch Co., et al. in Equity Docket A-3.

- 1. The source of water is Truckee River (Name of stream, lake or other source.)
2. The amount of water to be changed 175 c.f.s. not to exceed 40.5 acre-feet per season (Second feet, acre feet.)
3. The water to be used for domestic and municipal (If for stock state number and kind of animals.)
4. The water heretofore used for stock watering and irrigation (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point situate in the SE 1/4 SE 1/4 of Section 10, T19N R19E M.D.B.&M. at a point from which the SE corner of said Section 10 bears South 69°57'58" East 842.34 feet (Idlewild Pump Station)

6. The existing point of diversion is located within SE 1/4 NE 1/4 Section 14, T19N R18E M.D.B.&M. from which point the NE corner of said Section 14 bears North 24°26' East 1840.0 feet (Last Chance Ditch).

7. Proposed place of use (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.) T20N R19E M.D.B.&M. - Sections 34, 35 and 36 T20N R20E M.D.B.&M. - Sections 31, 32 and 33 T19N R20E M.D.B.&M. - Sections 4, 5, 6, 7, 8, 9, 17, 18, 19, 20 and 30 T19N R19E M.D.B.&M. - Sections 1, 2, 3, 4, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 21, 22, 23, 24, 25, 26 and 27.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner and place of use of the waters of the Truckee River as heretofore granted under Claim 172, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.175 cubic feet per second, but not to exceed 40.5 acre-feet per season.

Actual construction work shall begin on or before July 17, 1968

Proof of commencement of work shall be filed before August 17, 1968

Work must be prosecuted with reasonable diligence and be completed on or before July 17, 1969

Proof of completion of work shall be filed before August 17, 1969

Application of water to beneficial use shall be made on or before July 17, 1970
