APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This Permit to change the manner of use of the waters of an underground source as heretofore granted under Permit No. 19956 is issued subject to the terms and conditions imposed in said Permit No. 19956 and with the understanding that no other rights on the source will be affected by the change proposed herein. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. The State reserves the right to regulate the use of the water under this proposed change at any and all times. Any final water right issued under this Permit is dependent on the result of an adjudication of the water right claimed under Proof of Appropriation No. 02482.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second but not to exceed a total duty of 1,100 acre-feet annually from all sources supplying the place of use

Actual construction work shall begin on or before September 13, 1968  
Proof of commencement of work shall be filed before October 13, 1968  
Work must be prosecuted with reasonable diligence and be completed on or before September 13, 1968  
Proof of completion of work shall be filed before October 13, 1968  
Application of water to beneficial use shall be made on or before September 13, 1970  
Proof of the application of water to beneficial use shall be filed on or before October 13, 1970  
Map in support of proof of beneficial use shall be filed on or before October 13, 1970
