State of California, hereby makes application for permission to change the Point of Diversion

of water heretofore appropriated under Permit No. 21770

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is underground (Name of stream, lake or other source.)

2. The amount of water to be changed 5.4 c.f.s. (Second feet, acre feet.)

3. The water to be used for irrigation & domestic (If for stock state number and kind of animals.)

4. The water heretofore used for irrigation & domestic (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point NE 1/4 NE 1/4 Section 5, T. 33 N., R. 38 E., M.D.B.&M., or at a point from which the NE corner of the said Section 5 bears N. 45° E., a distance of 100 feet.

6. The existing point of diversion is located within SE 1/4 NE 1/4 Section 5, T. 33 N., R. 38 E., M.D.B.&M., or at a point from which the NE corner of said Section 5 bears N. 26° 30' E., a distance of 2,815 feet.

7. Proposed place of use East 1/2 of Section 5, T. 33 N., R. 38 E., M.D.B.&M. 320 acres

8. Existing place of use East 1/2 of Section 5, T. 33 N., R. 38 E., M.D.B.&M. 320 acres

9. Use will be from January 1 to December 31 of each year.

10. Use has been from January 1 to December 31 of each year.

11. Description of proposed works.

Drill 16 inch well, gravel pack with casing, install deep well turbine pump with electric motor, construct irrigation ditch system. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) (State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.)

12. Estimated cost of works at least \$1,000

13. Estimated time required to construct works 5 years

14. Remarks This application made in order to change the system of irrigation from overhead sprinklers to flood irrigation. Well to be located at the high point for gravity flow.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 21770 is issued subject to the terms and conditions imposed in said Permit 21770 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before October 3, 1968
Proof of commencement of work shall be filed before November 3, 1968
Work must be prosecuted with reasonable diligence and be completed on or before October 3, 1969
Proof of completion of work shall be filed before November 3, 1969
Application of water to beneficial use shall be made on or before October 3, 1972
Proof of the application of water to beneficial use shall be filed on or before November 3, 1972
Map in support of proof of beneficial use shall be filed on or before November 3, 1972
