point of diversion of a portion, the place of use and the manner of use

of water heretofore appropriated under 18070

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion, manner and place of use of a portion of the waters of an underground source as heretofore granted under Permit 18070 is issued subject to the terms and conditions imposed in said Permit 18070 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a parshall flume. The location of the latter to be approved by the State Engineer. If well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030; therefore, the State retains the right to regulate the use of the water herein granted at any and all times. The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.33 cubic feet per second, but not to exceed 667 acre-feet per season.

Actual construction work shall begin on or before July 10, 1968
Proof of commencement of work shall be filed before August 10, 1968
Work must be prosecuted with reasonable diligence and be completed on or before July 10, 1969
Proof of completion of work shall be filed before August 10, 1969
Application of water to beneficial use shall be made on or before July 10, 1970
Proof of the application of water to beneficial use shall be filed on or before August 10, 1970
Map in support of proof of beneficial use shall be filed on or before August 10, 1970
