The applicant Theodore H. Berry & James S. Payne of Box 805, Winnemucca, County of Humboldt, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is North Fork Spring Valley Creek (surface water) Name of stream, lake or other source.

2. The amount of water applied for is 5.0 second-feet One second-foot equals 448.83 gals. per min.

3. The water to be used for mining, milling & domestic Irrigation, power, mining, manufacturing, domestic, or other use.
