The applicant M & R Investment Co., Inc. of Las Vegas, County of Clark

State of Nevada, hereby makes application for permission to change the point of diversion

of water heretofore appropriated under Permit 14872, Certificate 4360

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Las Vegas Artesian Basin (Name of stream, lake or other source.)

2. The amount of water to be changed 0.10 c.f.s. not to exceed 4.5 m.g. per annum. (Second feet, acre feet.)

The water is to be diverted at the following point in the NE 1/4 SE 1/4 Section 20, T. 21 S., R. 61 E., M.D.B.&M., at a point from which the E 1/4 corner of said Section 20 bears N. 89° 05' 50" E 921 feet. (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

6. The existing point of diversion is located within NE 1/4 NE 1/4 Sec. 20, T. 21 S., R. 61 E., M.D.B.&M. at a point from which the northeast corner of said Section 20 bears N. 25° 07' E., 1260 feet. (If point of diversion is not changed, do not answer.)

7. Proposed place of use is in the NE 1/4 NE 1/4 Section 20, T. 21 S., R. 61 E., M.D.B.&M. County of Clark, State of Nevada. (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.)

8. Existing place of use NE 1/4 NE 1/4 Section 20, T. 21 S., R. 61 E., M.D.B.&M. County of Clark, State of Nevada. (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the

following limitations and conditions: This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 14872, Certificate 4360 is issued subject to the terms and conditions imposed in said Permit 14872, Certificate 4360 and with the understanding that no other rights on the source will be affected by the proposed change. The existing well covered under Permit 14872, Certificate 4360 must be plugged and sealed within thirty (30) days of the completion of the well which is the subject of this Permit. A meter must be installed in the discharge pipe line, near the point of diversion, immediately upon completion of the well and accurate measurements must be kept of the water placed to beneficial use. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.10 cubic feet per second but not to exceed 4.5 m.g. annually

Actual construction work shall begin on or before October 24, 1968

Proof of commencement of work shall be filed before November 24, 1968

Work must be prosecuted with reasonable diligence and be completed on or before October 24, 1969

Proof of completion of work shall be filed before November 24, 1969

Application of water to beneficial use shall be made on or before October 24, 1970

Proof of the application of water to beneficial use shall be filed on or before November 24, 1970
