The applicant Eureka Ranch Company of P. O. Box 38, Eureka, County of Eureka, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Partnership: A. B. Clements, J. W. Entz, D. C. Entz and T. C. Anderson.

1. The source of the proposed appropriation is Fish Creek Canyon Name of stream, lake or other source.

2. The amount of water applied for is 0.0156 second-foot One second-foot equals 448.83 gals. per min.

11. Remarks The applicant has constructed the reservoir in such a way that when the reservoir becomes full the excess water will flow via the spillway back into the natural channel. Fish Creek Canyon carries only flood waters and spring runoff.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of cattle served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0156 cubic feet per second or sufficient water to water 500 head of cattle

Actual construction work shall begin on or before April 25, 1969

Proof of commencement of work shall be filed before May 25, 1969

Work must be prosecuted with reasonable diligence and be completed on or before April 25, 1970

Proof of completion of work shall be filed before May 25, 1970

Application of water to beneficial use shall be made on or before April 25, 1971
