The applicant American Construction & Equipment Co., Inc. ASSIGNED of North Las Vegas, County of Clark

State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

August 2, 1957 - State of Nevada

1. The source of the proposed appropriation is Underground (L.V.A.B.) Name of stream, lake or other source.

2. The amount of water applied for is 0.10 c.f.s. second-foot One second-foot equals 448.83 gals. per min.

R62E., MDB&M., or at a point from which the S 1/4 corner of said Section 7 Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, bears S. 29°10'W., 1,335.2 feet. it should be stated.

6. Place of use Portion of SW 1/4 SE 1/4 Section 7, T20S., R62E., MDB&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, pump, and various size pipe to places of use. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste.

This source is located within an area designated by the State Engineer pursuant to NRS 534.030; therefore, the State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.10 cubic feet per second, but not to exceed 17.0 mg annually.

Actual construction work shall begin on or before April 30, 1969

Proof of commencement of work shall be filed before May 30, 1969

Work must be prosecuted with reasonable diligence and be completed on or before April 30, 1969

Proof of completion of work shall be filed before May 30, 1969

Application of water to beneficial use shall be made on or before April 30, 1972

Proof of the application of water to beneficial use shall be filed on or before May 30, 1972
