State of Nevada, hereby makes application for permission to change the Point of diversion, manner and place of use

of water heretofore appropriated under Permit 11156, Certificate 3143

- 1. The source of water is Underground (Las Vegas Artesian Basin)
2. The amount of water to be changed 0.292 c.f.s.
3. The water to be used for Recreation (Irrigation for Golf Course) and Domestic
4. The water heretofore used for General Hotel Supply and Domestic
5. The water is to be diverted at the following point in the NW 1/4 of the NE 1/4 of Section 16, T. 21 S., R. 61 E., M.D.B.&M., from which the N 1/4 corner of said Section 16 bears N. 37° 39' W., 1430 feet.
6. The existing point of diversion is located within the SE 1/4 of the SW 1/4 of Section 9, T. 21 S., R. 61 E., M.D.B.&M., or at a point from which the SW corner of said Section 9 bears S. 77° 54' W., 1422.4 feet.
7. Proposed place of use portions of the NE 1/4 of Section 16, T. 21 S., R. 61 E., M.D.B.&M.
8. Existing place of use NE 1/4 NW 1/4 and NW 1/4 NW 1/4 Section 16 and SE 1/4 SW 1/4 Section 9, T. 21 S., R. 61 E., M.D.B.&M.
9. Use will be from January 1st to December 31st of each year.
10. Use has been from January 1st to December 31st of each year.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion, manner and place of use of the waters of an underground source as heretofore granted under Permit 11157, Certificate 3275, is issued subject to the terms and conditions imposed in said Permit 11157, Certificate 3275, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.292 cubic feet per second

Actual construction work shall begin on or before June 9, 1969

Proof of commencement of work shall be filed before July 9, 1969

Work must be prosecuted with reasonable diligence and be completed on or before June 9, 1970

Proof of completion of work shall be filed before July 9, 1970

Application of water to beneficial use shall be made on or before June 9, 1972

Proof of the application of water to beneficial use shall be filed on or before July 9, 1972

Map in support of proof of beneficial use shall be filed on or before July 9, 1972
