The applicant White Pine Lumber Co. of 235 Ralston St., Reno, County of Washoe State of Nevada, hereby makes application for permission to change the place of use and manner of use

of water heretofore appropriated under Truckee River Decree - Equity Docket No. A-3 Claim #181 (208) (Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

- 1. The source of water is Truckee River (Name of stream, lake or other source.)
2. The amount of water to be changed 1.36 cfs not to exceed 547.20 acre feet (Second feet, acre feet.)
3. The water to be used for Recreational (Irrigation of Golf Course) and domestic (If for stock state number and kind of animals.)
4. The water heretofore used for Irrigation, stockwatering and domestic (If for stock state number and kind of animals.)
5. The water is to be diverted at the following point SE 1/4 NE 1/4 Sec. 14, T. 19 N., R. 18 E.,

M.D.B.&M. (Last Chance ditch) or at a point from which the NE corner of said Sec. 14 bears N. 24° 26' E., 1840.0 ft. (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the manner and place of use of the waters of the Truckee River as heretofore granted under Claim No. 181 (208), Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. The quantity of water to be changed shall be limited to the amount which can be applied to beneficial use and not to exceed 1.36 cfs., or 547.2 ac.ft., annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.36 cubic feet per second, but not to exceed 547.2 ac.ft., annually.

Actual construction work shall begin on or before September 27, 1969

Proof of commencement of work shall be filed before October 27, 1969

Work must be prosecuted with reasonable diligence and be completed on or before September 27, 1970

Proof of completion of work shall be filed before October 27, 1970

Application of water to beneficial use shall be made on or before September 27, 1972

Proof of the application of water to beneficial use shall be filed on or before October 27, 1972

Map in support of proof of beneficial use shall be filed on or before October 27, 1972
