The applicant K. L. Keltner of Las Vegas, County of Clark

State of Nevada, hereby makes application for permission to change the point of diversion and place of use of a portion of water heretofore appropriated under Permit 14299

1. The source of water is Underground Pahrump Artesian Basin (Name of stream, lake or other source.)

2. The amount of water to be changed 15 (Second feet, acre feet.)

6. The existing point of diversion is located within NW 1/4 NE 1/4 S. 8, T. 19 S., R. 53 E., M. D. B. & M., or at a point from which the N 1/4 Corner said Sec. 8 bears N. 79° 42' W., 447 ft. (If point of diversion is not changed, do not answer.)

7. Proposed place of use NE 1/4 NE 1/4 SW 1/4 Sec. 19, T. 21 S., R. 54 E., M. D. B. & M., Nye County, Nevada, 10 acres to be irrigated (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.)

8. Existing place of use W 1/2 NE 1/4 Sec. 8, and the NW 1/4 Sec. 8 and the NE 1/4 of Sec. 7, all in Township 19 South, Range 53 East, M. D. B. & M., Nye County, Nev. (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

9. Use will be from No Change (Month) to (Month) of each year.

10. Use has been from January 1 (Month) to December 31 (Month) of each year.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the

following limitations and conditions: This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 14299 is issued subject to the terms and conditions imposed in said Permit 14299 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a parshall flume. The location of the latter to be approved by the State Engineer. If well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030; therefore, the State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed .15 cubic feet per second, but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before January 25, 1970

Proof of commencement of work shall be filed before February 25, 1970

Work must be prosecuted with reasonable diligence and be completed on or before January 25, 1971

Proof of completion of work shall be filed before February 25, 1971

Application of water to beneficial use shall be made on or before January 25, 1973

Proof of the application of water to beneficial use shall be filed on or before February 25, 1973

Map in support of proof of beneficial use shall be filed on or before February 25, 1973
