The applicant Victor R. D. and Donna J. Hill of P.O. Box 392, Beatty, County of (Nye County) State of Nevada 89003, hereby makes application for permission to change the Point of Diversion of water heretofore appropriated under Permit 19217

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Underground (Name of stream, lake or other source.)

2. The amount of water to be changed 2.45 cfs (See Remarks) (Second feet, acre feet.)

6. The existing point of diversion is located within NW 1/4 SW 1/4 Sec. 10, T16S, R48E, M.D.B.&M, or at a point from which the W 1/4 corner of said Sec. 10 bears N. 45 degrees W., a distance of 1810.0 feet. (Permitted location)

7. Proposed place of use (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.) NW 1/4 NW 1/4 SW 1/4 Sec. 10, T16S, R48E, M.D.B.&M., (10 ac.) SE 1/4 " " " " " " " " (10 ac.) W 1/2 NE 1/4 " " " " " " " " (5 ac.) Total 25 ac.

8. Existing place of use Same as #7 above except that 22.5 of the said 25 acres are presently cultivated. (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

9. Use will be from Jan 1 (Month) to Dec 31 (Month) of each year.

10. Use has been from Jan 1 (Month) to Dec 31 (Month) of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the Point of Diversion of the waters of an underground source as heretofore granted under Permit 19217 is issued subject to the terms and conditions imposed in said Permit 19217 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.57 cubic feet per second, but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before August 4, 1975

Proof of commencement of work shall be filed before September 4, 1975

Work must be prosecuted with reasonable diligence and be completed on or before August 4, 1976

Proof of completion of work shall be filed before September 4, 1976

Application of water to beneficial use shall be made on or before August 4, 1977

Proof of the application of water to beneficial use shall be filed on or before September 4, 1977

Map in support of proof of beneficial use shall be filed on or before September 4, 1977
