This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the Point of Diversion, manner and place of use of the waters of the Truckee River as heretofore granted under Claim No. 514, Truckee River Final Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.55 cubic feet per second but not to exceed 638.6 acre feet as decreed.

Actual construction work shall begin on or before March 29, 1970

Proof of commencement of work shall be filed before April 29, 1970

Work must be prosecuted with reasonable diligence and be completed on or before March 29, 1971
