- 1. The source of the proposed appropriation is Underground
2. The amount of water applied for is 10.2 second-feet
3. The water to be used for Irrigation
4. If use is for: (a) Irrigation (state number of acres to be irrigated) 600 acres
5. The water is to be diverted from its source at the following point: SW 1/4 of the NE 1/4 of Section 18
6. Place of use S 1/2 of the S 1/2 of Section 8; SW 1/4 SW 1/4 of Section 9; NW 1/4, N 1/2 NE 1/4, SW 1/4 NE 1/4 of Section 17; E 1/2 NE 1/4 and SW 1/4 NE 1/4 of Section 18, T.16N., R.42E., M.D.B. & M.
7. Use will begin about January 1 and end about December 31, of each year.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

No perforations shall be put in the casing until after the well is completed and the log available for study. Perforations shall not start less than 100 feet from the surface unless the log shows a satisfactory confining formation nearer the surface.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 6.0..... cubic feet per second but not to exceed a yearly duty of 4.0 acre feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before..... October 17, 1970.....

Proof of commencement of work shall be filed before..... November 17, 1970.....

Work must be prosecuted with reasonable diligence and be completed on or before..... October 17, 1971.....

Proof of completion of work shall be filed before..... November 17, 1971.....

Application of water to beneficial use shall be made on or before..... October 17, 1974.....

Proof of the application of water to beneficial use shall be filed on or before..... November 17, 1974.....
