

APPLICATION FOR PERMISSION TO CHANGE POINT OF DIVERSION, MANNER OF USE AND PLACE OF USE OF THE PUBLIC WATERS OF THE STATE OF NEVADA HERETOFORE APPROPRIATED

The applicant Lander Farms, Inc. of 1535 11th Street, Firebaugh, County of California, hereby makes application for permission to change the point of diversion and place of use of water heretofore appropriated under Permit 24082

1. The source of water is Underground (Name of stream, lake or other source.)

2. The amount of water to be changed 5.4 c.f.s. (Second feet, acre feet.)

5. The water is to be diverted at the following point. In the SE 1/4 NE 1/4, Section 27, T.25N., R.42E., M.D.B. & M., or at a point from which the E 1/2 corner of said Sec. 27 bears S. 45° 00' E. A distance of 100 feet

6. The existing point of diversion is located within SE 1/4 NE 1/4 Sec. 22, T.25N., R.42E., M.D.B. & M., or at a point from which the E 1/2 corner of said Sec. 22 bears S. 84° 18' E. a distance of 603 feet (If point of diversion is not changed, do not answer.)

7. Proposed place of use. SE 1/4 Sec. 22 and the NE 1/4 Sec. 27, all in T.25N., R.42E., M.D.B. & M., (320 acres) (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.)

8. Existing place of use. E 1/2 Sec. 22, T.25N., R.42E., M.D.B. & M. (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

9. Use will be from January 1st to December 31st of each year. (Month) (Month)

10. Use has been from January 1st to December 31st of each year. (Month) (Month)

11. Description of proposed works.

Pump, well, and irrigation system flood irrigation.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 24082 is issued subject to the terms and conditions imposed in said Permit 24082 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before October 6, 1970
Proof of commencement of work shall be filed before November 6, 1970
Work must be prosecuted with reasonable diligence and be completed on or before October 6, 1971
Proof of completion of work shall be filed before November 6, 1971
Application of water to beneficial use shall be made on or before October 6, 1974
Proof of the application of water to beneficial use shall be filed on or before November 6, 1974
Map in support of proof of beneficial use shall be filed on or before November 6, 1974
