

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Cactus Pete's, Inc. of c/o Chilton Engineering, County of Elko, State of Nevada 89801, hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Incorporated - 1965, Nevada

1. The source of the proposed appropriation is Underground Well No. 1 Name of stream, lake or other source.

2. The amount of water applied for is 1.0 cfs second-foot One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Commercial & Domestic Irrigation, power, mining, manufacturing, domestic, or other use.

The water is to be diverted from its source at the following point: NW 1/4 NW 1/4, Section 12, T. 47 N., R. 64 E., M.D.B. & M., at a point from which the NW corner of said Section 12 bears N. 83° 22' W., 1310 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use Portions of SW 1/4, Section 1 and NW 1/4, Section 12, T. 47 N., R. 64 E., M.D.B. & M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1st and end about December 31st, of each year. Month Month

Drilled and cased well, install submersible pump and connect to place of use by underground piping. APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times. The water from this well and the well under Permit 25428 is to be commingled and the total duty from both wells shall not exceed 6.24 m.g.a.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second but not to exceed 6.24 m.g. annually
