

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant William Stock Farming Co. of Paradise Valley, County of

State of Nevada 89426, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) January 1909, State of Nevada

1. The source of the proposed appropriation is underground. Name of stream, lake or other source.

2. The amount of water applied for is 4.7 second-feet. One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet. acre-feet

3. The water to be used for irrigation. Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 280

(b) Stockwater (state number and kinds of animals to be watered)

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: SW 1/4 NW 1/4 Sec. 9, T.41N., R.40E., M.D.B.&M., or a point from which the west 1/4 corner of said Section 9 bears S. 15° 17' W., 1601 ft. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use S 1/2 NW 1/4, SW 1/4 NE 1/4, W 1/2 SE 1/4, E 1/2 SW 1/4 Section 9, T.41N., R.40E., M.D.B.&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about March 15 and end about Nov. 1, of each year. Month Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pump, pipe lines and ditches. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.7 cubic feet per second but not to exceed a seasonal duty of 3.6 acre feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before July 19, 1972

Proof of commencement of work shall be filed before August 19, 1972

Work must be prosecuted with reasonable diligence and be completed on or before July 19, 1973

Proof of completion of work shall be filed before August 19, 1973

Application of water to beneficial use shall be made on or before July 19, 1976

Proof of the application of water to beneficial use shall be filed on or before August 19, 1976

Map in support of proof of beneficial use shall be filed on or before August 19, 1976
