This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 25733 is issued subject to the terms and conditions imposed in said Permit 25733 and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.279 cubic feet per second, but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before November 29, 1980
Proof of commencement of work shall be filed before December 29, 1980
Work must be prosecuted with reasonable diligence and be completed on or before November 29, 1981
Proof of completion of work shall be filed before December 29, 1981
Application of water to beneficial use shall be made on or before November 29, 1982
