The applicant Loui and Leo Cerri of Box 26, Paradise Valley, County of Nevada State of Nevada hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. 6. Place of use SW 1/4, W 1/2 SE 1/4 of Sec. 17; E 1/2 SE 1/4 of Sec. 18, E 1/2 NE 1/4 Sec. 19; W 1/2, W 1/2 E 1/2, E 1/2 SE 1/4 of Sec. 20 all in T. 42N., R. 40E. MDB&M

7. Use will begin about Jan. 1 and end about Dec. 31, of each year.

..... APPROVAL ..... OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. If the well is flowing, a valve must be installed and maintained to prevent waste. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained will be dependent upon the amount of water actually placed to beneficial use. It is further understood that this right must allow for a reasonable lowering of the static water level at the permittee's well due to any other ground water development in the area. A measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depths to water. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 6.0 cubic feet per second, but not to exceed 3.6 acre-feet annually per acre of land irrigated from any and/or all sources.
