

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Grant J. Weise of P. O. Box 1847, County of Carson City, State of Nevada 89701, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground - Well No. 5. Name of stream, lake or other source.

2. The amount of water applied for is 1.0 second-foot. One second-foot equals 448.83 gals. per min. (a) If stored in reservoir give number of acre-feet. acre-feet

3. The water to be used for Quasi - Municipal, Subdivisions. Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated). (b) Stockwater (state number and kinds of animals to be watered). (c) Other use (describe fully under "No. 12. Remarks"). (d) Power: (1) Horsepower developed. (2) Point of return of water to stream.

5. The water is to be diverted from its source at the following point: in the SE 1/4 SE 1/4 Sec. 2 T. 15N., R. 19E. from which the southeast corner of said section 2 bears S. 29° 32' E. 310.00 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use Portions of S 1/2 section 2, T. 15N., R. 19E., M.D.B.&M. and 1/2 SW 1/4 section 1, T. 15N., R. 19E., M.D.B.&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1st and end about December 31st, of each year. Month Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well casing, pump, pressure storage tank and pipelines. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The combined total duty of water under this permit and Permits 26493, 26494, 26495, 26496 shall not exceed 1,460.0 million gallons annually.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second, the combined total duty of water under this permit and Permits 26493, 26494, 26495, 26496 shall not exceed 1,460.0 million gallons annually.
