State of Nevada 89105, hereby makes application for permission to change the Manner of Use and Place of Use

of water heretofore appropriated under Permit No. 24598

1. The source of water is underground (Name of stream, lake or other source.)

2. The amount of water to be changed 4.6 cubic feet per second (Second feet, acre feet.)

The water is to be diverted at the following point In the NE 1/4 NW 1/4 Sec. 9, T-12-N, R-62-E, M.D.M. at a point from which the SW corner of said Section 9 bears S. 26° 12' 41" W., 5,762.50 feet distant. (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

6. The existing point of diversion is located within In the NE 1/4 NW 1/4 Section 9, T-12-N, R-62-E, M.D.M. at a point from which the SW corner of said Section 9 bears S. 26° 12' 41" W., 5,762.50 feet distant. (If point of diversion is not changed, do not answer.)

Description of proposed works. 500,000 gallon Reservoir, 12" and smaller water mains, electrical pumping equipment, and complete distribution system to serve approximately 600 residential estate lots, 300 trailer estate lots, an overnight trailer park, condominium housing, and commercial lots to be developed on this 800 acre site.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the manner and place of use of the waters of an underground source as heretofore granted under Permit 24598 is issued subject to the terms and conditions imposed in said Permit 24598 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under this permit and permits 27025 and 27027 thru 27031 shall not exceed 3200.0 acre-feet annually. This permit is also issued subject to the terms and conditions set forth in the State Engineer's ruling of April 6, 1973.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.6 cubic feet per second, but not to exceed 1091.6 acre-feet annually.

Actual construction work shall begin on or before June 9, 1973

Proof of commencement of work shall be filed before July 9, 1973

Work must be prosecuted with reasonable diligence and be completed on or before June 9, 1973

Proof of completion of work shall be filed before July 9, 1973

Application of water to beneficial use shall be made on or before June 9, 1976

Proof of the application of water to beneficial use shall be filed on or before July 9, 1976

Map in support of proof of beneficial use shall be filed on or before July 9, 1976
