The applicant James F. Kearns of P. O. Box 32, Winnemucca, County of Nevada 89445, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is underground. Name of stream, lake or other source.

2. The amount of water applied for is 10 cfs second-feet. One second-foot equals 448.83 gals. per min.

Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use N 1/2 & SW 1/4 of Section 17, T 37 N., R. 39E., M.D.B. & M. 480 ac. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about 1 January and end about 31 December, of each year. Month Month
