The applicant H H & W Oil Company of 2863 Walnut Avenue, County of Long Beach State of California, hereby makes application for permission to change the point of diversion and place of use of water heretofore appropriated under 24102

1. The source of water is Underground (Name of stream, lake or other source.)

2. The amount of water to be changed 5.4 c.f.s. (Second feet, acre feet.)

7. Proposed place of use West 1/2 of Section 7, T 32N, R 38E, MDB&M, 320 Acres (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.)

8. Existing place of use East 1/2 of Section 7, T 32N, R 38E, MDB&M, 320 Acres (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

Drilled 16" well, gravel pack, with casing, install deep well turbine pump and electric motor, construct irrigation ditch system.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the Point of Diversion and Place of Use of the waters of an underground source as heretofore granted under Permit 24102 is issued subject to the terms and conditions imposed in said Permit 24102 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, but not to exceed a

yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before March 19, 1974

Proof of commencement of work shall be filed before April 19, 1974

Work must be prosecuted with reasonable diligence and be completed on or before March 19, 1975

Proof of completion of work shall be filed before April 19, 1975

Application of water to beneficial use shall be made on or before March 19, 1978

Proof of the application of water to beneficial use shall be filed on or before April 19, 1978

Map in support of proof of beneficial use shall be filed on or before April 19, 1978
