The applicant M & R Investment Co., Inc. (dba Dunes Hotel) of 3650 Las Vegas Boulevard South, County of Las Vegas

State of Nevada, hereby makes application for permission to change the Point of Diversion, Place of Use and Manner of Use

of water heretofore appropriated under Permit No. 12809 Certificate No. 5144

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is underground (Las Vegas Artesian Basin) (Name of stream, lake or other source.)

2. The amount of water to be changed 0.45 c.f.s., 133.33 acre feet annually (Second feet, acre feet.)

6. The existing point of diversion is located within the NW 1/4 NE 1/4 Sec. 4, T.21S. R.62E., MDB&M or at a point from which the N 1/4 corner of said Section 4 bears N 33° 59' 20" W 71.20 feet. (If point of diversion is not changed, do not answer.)

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the

following limitations and conditions: This permit to change the point of diversion, manner and place of use of a portion of the waters of an underground source as heretofore granted under Permit 12809 is issued subject to the terms and conditions imposed in said Permit 12809 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.45 cubic feet per second, but not to exceed 133.33 acre-feet annually.

Actual construction work shall begin on or before November 27, 1973

Proof of commencement of work shall be filed before December 27, 1973

Work must be prosecuted with reasonable diligence and be completed on or before November 27, 1973

Proof of completion of work shall be filed before December 27, 1973

Application of water to beneficial use shall be made on or before November 27, 1974

Proof of the application of water to beneficial use shall be filed on or before December 27, 1974

Map in support of proof of beneficial use shall be filed on or before December 27, 1974
