of water heretofore appropriated under Claim #570 of the Truckee River Decree being the decree entered by the District Court of the United States for Nevada in the case of US vs Orr Water Ditch Company, et al, in Equity Docket A-3.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the Manner of Use and Place of Use of the waters of the Truckee River as heretofore granted under Claim 570, Truckee River Final Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.66 cubic feet per second, or 628.0 acre-feet per season.

Actual construction work shall begin on or before April 25, 1975

Proof of commencement of work shall be filed before May 25, 1975

Work must be prosecuted with reasonable diligence and be completed on or before April 25, 1976

Proof of completion of work shall be filed before May 25, 1976

Application of water to beneficial use shall be made on or before April 25, 1977
