point of diversion of a portion

of water heretofore appropriated under Permit #25960

1. The source of water is Underground Name of stream, lake or other source.

2. The amount of water to be changed 3.0 c.f.s. Second feet, acre feet.

3. The water to be used for Irrigation and domestic If for stock state number and kind of animals.

4. The water heretofore used for Irrigation and domestic If for stock state number and kind of animals.

5. The water is to be diverted at the following point in the NE 1/4 NE 1/4 of Sec. 35, T.38N., R.38E., M.D.B.&M. at a point from which the NE corner of said Section 35 bears N. 2° 37' 15" E. a distance of 1300 feet. Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. The existing point of diversion is located within SW 1/4 NE 1/4 Sec. 35, T.38N., R.38E., M.D.B.&M. or at a point from which the S 1/4 corner of said section bears S. 0° 28' W., 3700 feet. If point of diversion is not changed, do not answer.


7. Proposed place of use Sections 23, 24, 25, 26 and 35, T.38N., R.38E., M.D.B.&M. Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.

8. Existing place of use Sections 23, 24, 25, 26 and 35, T.38N., R.38E., M.D.B.&M. Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.

9. Use will be from January 1 to December 31 of each year. Day and Month Day and Month

10. Use has been from January 1 to December 31 of each year. Day and Month Day and Month

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Proposed to drill 18 inch well with casing, and install a deep well pump with electric motor and pressure sprinkler system. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.



12. Estimated cost of works at least \$10,000.00
13. Estimated time required to construct works 30 days
14. Estimated time required to complete the application of water to beneficial use 5 years
15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

Water under this application is to be comingled with water under other applications made by the applicant.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the Point of Diversion of a portion of the waters of an underground source as heretofore granted under Permit 25960 is issued subject to the terms and conditions imposed in said Permit 25960 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before April 9, 1975

Proof of commencement of work shall be filed before May 9, 1975

Work must be prosecuted with reasonable diligence and be completed on or before April 9, 1976

Proof of completion of work shall be filed before May 9, 1976

Application of water to beneficial use shall be made on or before September 29, 1976

Proof of the application of water to beneficial use shall be filed on or before October 29, 1976

Map in support of proof of beneficial use shall be filed on or before October 29, 1976

Commencement of work filed AUG 18 1975  
Completion of work filed MAY 5 1976  
Proof of beneficial use filed JUL 1 1977
