hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) October 5, 1973, Nevada

1. The source of the proposed appropriation is Underground

2. The amount of water applied for is 1.0 second-feet
One second-foot equals 448.83 gals. per min.

3. The water to be used for Mining, Milling and Domestic
Irrigation, power, mining, manufacturing, domestic, or other use.

5. The water is to be diverted from its source at the following point: NW 1/4 SW 1/4, Section 35,

T. 29N., R. 34E., M.D.B.&M., or at a point from which the Southwest corner of said Section 35 bears South 30° 47' West, a distance of 1980 feet.
Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use Lots 7, 8, 11 and 12 of Section 1, T. 28N., R. 34E., M.D.B.&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Water will be diverted by pump and motor to 8" pipeline which will convey it to the place of use as shown on the supporting map.

9. Estimated cost of works.....\$5,000
10. Estimated time required to construct works..... 3 years
11. Estimated time required to complete the application to beneficial use..... 5 years

Water to be used in mining and milling operation which will rework large volumes of tailings left from early mining in the area. Total water needs are not presently known, but may be as high as 1000 gpm during periods of peak use. Estimated annual needs 750 Ac.-Ft.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water granted herein at any and all times.

The total combined duty of water under Permits 28122 through 28130 shall not exceed 750.0 acre-feet per annum.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second but not to exceed 750.0 acre-feet annually.

- Actual construction work shall begin on or before March 23, 1976
- Proof of commencement of work shall be filed before April 23, 1976
- Work must be prosecuted with reasonable diligence and be completed on or before March 23, 1977
- Proof of completion of work shall be filed before April 23, 1977
- Application of water to beneficial use shall be made on or before March 23, 1979
- Proof of the application of water to beneficial use shall be filed on or before April 23, 1979
- Map in support of proof of beneficial use shall be filed on or before.....
