

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant R. N. Fulstone Co. Box 61 of Smith Nevada 89430, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Nevada 1957

1. The source of the proposed appropriation is Underground Name of stream, lake or other source.

2. The amount of water applied for is 6.0 cfs. second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Irrigation and domestic Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated) 360 (b) Stockwater (state number and kinds of animals to be watered) (c) Other use (describe fully under "No. 12. Remarks") (d) Power:

(1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: in the SE 1/4 NW 1/4 Section 1, T. 12N., R. 25E., M.D.B. & M., from which the northeast corner of said section 1 bears N. 45° 45' 47" E., 3761.34 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use NW 1/4 section 1; E 1/2 NE 1/4 Section 2, T. 12N., R. 25E., and S 1/2 SW 1/4 section 36; and SE 1/4 SE 1/4 section 35, T. 13N., R. 25E., M.D.B. & M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1st. and end about December 31st. of each year. Day and Month Day and Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well, casing, pump, pipelines and ditches State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

- 9. Estimated cost of works ..... \$21,000.00
- 10. Estimated time required to construct works ..... 2 years
- 11. Estimated time required to complete the application to beneficial use ..... 5 years
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:


This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 6.0 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Proof of commencement of work shall be filed before ..... January 17, 1975
- Work must be prosecuted with reasonable diligence and be completed on or before December 17, 1975
- Proof of completion of work shall be filed before ..... January 17, 1976
- Application of water to beneficial use shall be made on or before ..... December 17, 1978
- Proof of the application of water to beneficial use shall be filed on or before ..... January 17, 1979
- Map in support of proof of beneficial use shall be filed on or before ..... January 17, 1979
