The applicant Intermountain Land Co., 201 West Liberty Street, of Reno, Nevada 89501, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Robert W. Marshall and Nanette Marshall, Robert Dickenson and Dorothy Dickenson, and C.A.A.D. Rentals, a partnership, doing business as INTERMOUNTAIN LAND CO.

2. The amount of water applied for is 8.0 second-feet (a) If stored in reservoir give number of acre-feet

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:


This permit is issued subject to all existing rights on the source. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 8.0 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before..... December 25, 1976
- Proof of commencement of work shall be filed before..... January 25, 1977
- Work must be prosecuted with reasonable diligence and be completed on or before..... December 25, 1977
- Proof of completion of work shall be filed before..... January 25, 1978
- Application of water to beneficial use shall be made on or before..... December 25, 1980
- Proof of the application of water to beneficial use shall be filed on or before..... January 25, 1981
- Map in support of proof of beneficial use shall be filed on or before..... January 25, 1981
