The applicant Vernon & Joan Westwood %Chilton Engineering 421 Court, of Elko Nevada 89801, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Johnson Creek S Name of stream, lake or other source.

2. The amount of water applied for is 1.0 cfs second-foot One second-foot equals 448.83 gals. per min.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0125 cubic feet per second, or sufficient water to water 300 head of cattle and 100 head of horses.

Actual construction work shall begin on or before..... September 17, 1975

Proof of commencement of work shall be filed before..... October 17, 1975

Work must be prosecuted with reasonable diligence and be completed on or before..... September 17, 1976

Proof of completion of work shall be filed before..... October 17, 1976
