The applicant Vernon & Joan Westwood of Elko Nevada 89801 hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Unnamed Stream #3

2. The amount of water applied for is 3.0 cfs second-foot

(a) If stored in reservoir give number of acre-feet

3. The water to be used for Irrigation

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 440 acres

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: SE 1/4 NE 1/4, Sec. 28, T.35N., R.62E., M.D.M., at a point from which the E 1/4 corner of said Section 28 bears S 51° 00' E 1606.0 feet

6. Place of use SE 1/4 NE 1/4, E 1/2 SE 1/4, Section 28; SW 1/4, SE 1/4, S 1/2 NW 1/4 Sec. 27, T.35N., R.62E., M.D.M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) construct diversion box and ditches to place of use

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before September 17, 1975  
 Proof of commencement of work shall be filed before October 17, 1975  
 Work must be prosecuted with reasonable diligence and be completed on or before September 17, 1976  
 Proof of completion of work shall be filed before October 17, 1976  
 Application of water to beneficial use shall be made on or before September 17, 1979  
 Proof of the application of water to beneficial use shall be filed on or before October 17, 1979  
 Map in support of proof of beneficial use shall be filed on or before October 17, 1979
