hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Unnamed Stream #1 - S

2. The amount of water applied for is 1.0 cfs second-foot

(a) If stored in reservoir give number of acre-feet acre-foot

3. The water to be used for Stockwater Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated)

(b) Stockwater (state number and kinds of animals to be watered) 300 head cattle & 100 head horses

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power: (1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: NW 1/4 NE 1/4, Sec. 27, T35N, R62E, MDM, at a point from which the N 1/4 corner of said Section 27 bears N 89° 09' W 359.0 feet

6. Place of use All of Section 27, T35 N, R 62 E, MDM

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Construct diversion box along with ditches to place of use

9. Estimated cost of works..... \$2,000.00
10. Estimated time required to construct works..... 1 year
11. Estimated time required to complete the application to beneficial use..... 3 years

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.0125..... cubic feet per second, or sufficient water to water 300 head of cattle and 100 head of horses.

Actual construction work shall begin on or before..... May 4, 1975

Work must be prosecuted with reasonable diligence and be completed on or before..... May 4, 1976
