RULING NO. BY letter APPROVAL OF STATE ENGINEER
DATE APR 17 1998

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 28073 is issued subject to the terms and conditions imposed in said Permit 28073 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The total combined amount of water granted under this permit and Permits 28446, 28071, 28075, 27667, 28772 through 28776 is limited to what the well covered under these permits is capable of producing. If certificates of appropriation are issued under this permit and Permits 28446, 28071, 28075, 27667, 28772 through 28776, the total combined amount of appropriation granted in said certificates shall not exceed what the well covered under these permits is capable of producing.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before April 26, 1975

Proof of commencement of work shall be filed before May 26, 1975

Work must be prosecuted with reasonable diligence and be completed on or before April 26, 1975

Proof of completion of work shall be filed before May 26, 1975

Application of water to beneficial use shall be made on or before July 9, 1975

Proof of the application of water to beneficial use shall be filed on or before August 9, 1975

Map in support of proof of beneficial use shall be filed on or before August 9, 1975
