Nevada 89701, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) State and Zip Code No.

1. The source of the proposed appropriation is Bunkowski Spring No. 1 Name of stream, lake or other source.

2. The amount of water applied for is 0.40 second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Quasi-Municipal (Subdivision) and domestic Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for:

(a) Irrigation (state number of acres to be irrigated)

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: in the SE 1/4 NW 1/4 Sec. 23, T.16N., R.20E., M.D.B.&M., from which the south one quarter corner Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, of section 24, T.16N., R.20E., bears S. 57°34'42" E., 6487.64 feet. it should be stated.

6. Place of use Portions of sections 24, 25 and 36, T.16N., R.20E., and sections 31 and 30, T.16N., R.21E., M.D.B.&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1st and end about December 31st, of each year. Day and Month Day and Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) develop spring area, install collection box, pipelines, storage tank and distribution system. This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the 0.40 c.f.s., herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to a beneficial use. A suitable measuring device must be installed and accurate measurements of the water placed to a beneficial use must be included in the proof of such use when filed. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under this permit and Permits 28468, 28469, 28470, 28471, 24387, 24388, 24472, 25454, 25483, 25484, 26008, 26189, 26755, 27199, 27202, 27203, 27204, 28080, 28081, 28082, 28083, 28084, 28085, 28529, 28530 shall not exceed 730 million gallons per annum.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and

not to exceed 0.40 cubic feet per second, but not to exceed

94.36 million gallons annually.

Actual construction work shall begin on or before July 16, 1975

Proof of commencement of work shall be filed before August 16, 1975

Work must be prosecuted with reasonable diligence and be completed on or before July 16, 1976

Proof of completion of work shall be filed before August 16, 1976

Application of water to beneficial use shall be made on or before July 16, 1979

Proof of the application of water to beneficial use shall be filed on or before August 16, 1979

Map in support of proof of beneficial use shall be filed on or before

Commencement of work filed SEP 4 1975

Completion of work filed SEP 9 1976
