1. The source of water is Underground Name of stream, lake or other source.

6. The existing point of diversion is located within NW 1/4 SE 1/4 of Sec. 21, T.41N., R.37E., M.D.B.&M. or at a point from which the W 1/4 corner of said Sec. 21 bears N. 88° 58' W. a distance of 2628.8 ft. If point of diversion is not changed, do not answer.

7. Proposed place of use N 1/2 SW 1/4, SW 1/4 SW 1/4 Sec. 21, NW 1/4 NW 1/4 Sec. 28 T.41N., R.37E. Describe by legal subdivisions. If for irrigation state number of acres to be irrigated. M.D.B.&M. 151.40 acres

8. Existing place of use NW 1/4 NW 1/4 Sec. 28; SE 1/4 Sec. 20 N 1/2 SW 1/4 and the SW 1/4 SW 1/4 of Sec. 21 all in T.41N., R.37E., M.D.B.&M. 307.51 acres. Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.

9. Use will be from May 1st to Sept. 30 of each year. Day and Month Day and Month

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of a portion of the waters of an underground source as heretofore granted under Permit 21087 is issued subject to the terms and conditions imposed in said Permit 21087 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.8 cubic feet per second but not to exceed 241.32 acre-feet seasonally.

Actual construction work shall begin on or before September 16, 1976

Proof of commencement of work shall be filed before October 16, 1976

Work must be prosecuted with reasonable diligence and be completed on or before September 16, 1977

Proof of completion of work shall be filed before October 16, 1977

Application of water to beneficial use shall be made on or before September 16, 1979

Proof of the application of water to beneficial use shall be filed on or before October 16, 1979

Map in support of proof of beneficial use shall be filed on or before October 16, 1979
