hereby make application for permission to change the Point of Diversion and Place of Use

of water heretofore appropriated under Permit No. 25144

1. The source of water is Underground Name of stream, lake or other source.

2. The amount of water to be changed 4.615 c.f.s. Second feet, acre feet.

3. The water to be used for Irrigation If for stock state number and kind of animals.

4. The water heretofore used for Irrigation If for stock state number and kind of animals.

5. The water is to be diverted at the following point SE 1/4 NE 1/4 of Section 28, T.41N., R.40 E., M.D.B. & M., or at a point from which the S 1/4 corner of Section 33, T.41N., R.40E., M.D.B. & M. bears S. 16° 16' 36" W., 9,133.59 feet.

6. The existing point of diversion is located within SE 1/4 NE 1/4 of Section 28, T.41N., R.40E., M.D.B. & M., or at a point from which the S 1/4 corner of Section 33, T.41N., R.40E., M.D.B. & M., bears S. 16° 13' 16" W., 9,548.50 feet.

7. Proposed place of use Portions of the S 1/2 NW 1/4, SW 1/4 NE 1/4, SW 1/4 and the W 1/2 SE 1/4 of Section 28; SE 1/4 of Section 29; NE 1/4 of Section 32; NW 1/4, W 1/2 NE 1/4, N 1/2 SW 1/4, and the SW 1/4 SW 1/4 of Section 33; all in T.41N., R.40E., M.D.B. & M. (600 acres)

8. Existing place of use SW 1/4, S 1/2 NW 1/4 of Section 23; N 1/2 NW 1/4 of Section 26; N 1/2 SW 1/4, SW 1/4 SW 1/4, N 1/2 of Section 27; all of Section 28; N 1/2 SE 1/4, NE 1/4 NE 1/4 of Section 29; NE 1/4, N 1/2 SE 1/4 of Section 32; NW 1/4 NW 1/4 of Section 34; N 1/2, SW 1/4, NW 1/4 SE 1/4 of Section 33; all in T.41N., R.40E., M.D.B. & M. (600 acres)

9. Use will be from January 1 to December 31 of each year.

10. Use has been from January 1 to December 31 of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 25144 is issued subject to the terms and conditions imposed in said Permit 25144 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.615 cubic feet per second, but not to exceed a yearly duty of 3.6 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before October 15, 1975
- Proof of commencement of work shall be filed before November 15, 1975
- Work must be prosecuted with reasonable diligence and be completed on or before March 27, 1976
- Proof of completion of work shall be filed before April 27, 1976
- Application of water to beneficial use shall be made on or before March 27, 1976
- Proof of the application of water to beneficial use shall be filed on or before April 27, 1976
- Map in support of proof of beneficial use shall be filed on or before April 27, 1976
