APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. The State retains the right to regulate the use of the water herein granted at any and all times.


This permit is issued subject to the State Engineer's Ruling of May 2, 1975 and limited to 130 acres of land.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.7 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before November 2, 1975
- Proof of commencement of work shall be filed before December 2, 1975
- Work must be prosecuted with reasonable diligence and be completed on or before November 2, 1975
- Proof of completion of work shall be filed before December 2, 1975
- Application of water to beneficial use shall be made on or before November 2, 1977
- Proof of the application of water to beneficial use shall be filed on or before December 2, 1977
- Map in support of proof of beneficial use shall be filed on or before December 2, 1977
