Point of Diversion and Place of Use

of water heretofore appropriated under Permit No. 13690

- 1. The source of water is an underground source
2. The amount of water to be changed 0.06 cfs not to exceed 18.0 ac. ft. per year
3. The water to be used for irrigation and domestic purposes
4. The water heretofore used for irrigation and domestic purpose
5. The water is to be diverted at the following point within the NE 1/4 NW 1/4 of Section 1, T.21S., R.53E., M.D.B.&M., at a point from which the North Quarter (N 1/4) corner of said Section 1 bears N. 66 degrees 20' E. a distance of 1180.0 feet.
6. The existing point of diversion is located within NE 1/4 NW 1/4 of Section 1, T.21S., R.53E., M.D.B.&M. at a point from which the North Quarter (N 1/4) corner of said Section 1 bears N. 04 degrees 23' E. a distance of 208.0 feet.
7. Proposed place of use a portion of the NE 1/4 NW 1/4 of Section 1, T.21S., R.53E., M.D.B.&M. (being Lot 34 of the Moorhead Ranch Estates Subdivision).
8. Existing place of use a portion of the SW 1/4 NW 1/4 of Section 1, T.21S., R.53E., M.D.B.&M. 3.6 acres shall be removed from Permit No. 13690 upon approval of this application.
9. Use will be from January 1st to December 31st of each year.
10. Use has been from January 1st to December 31st of each year.
11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well, submersible pump and 1,000 feet of water line.

12. Estimated cost of works \$5,000.00
13. Estimated time required to construct works 3 years
14. Estimated time required to complete the application of water to beneficial use 5 years
15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This application is made to complete the transfer of water rights to the new owner of Lot 37 of Moorhead Ranch Estates Subdivision.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 13690, Certificate 5305 is issued subject to the terms and conditions imposed in said Permit 13690, Certificate 5305 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.06 cubic feet per second but not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before August 2, 1976

Proof of commencement of work shall be filed before September 2, 1976

Work must be prosecuted with reasonable diligence and be completed on or before August 2, 1977

Proof of completion of work shall be filed before September 2, 1977

Application of water to beneficial use shall be made on or before August 2, 1978

Proof of the application of water to beneficial use shall be filed on or before September 2, 1978

Map in support of proof of beneficial use shall be filed on or before September 2, 1978
