hereby make application for permission to change the Point of Diversion and Place of Use of a portion

of water heretofore appropriated under Permit No. 26957

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Underground Well - Well "A" Name of stream, lake or other source.

2. The amount of water to be changed 0.5 cfs Second feet, acre feet.

3. The water to be used for Quasi-Municipal and Domestic If for stock state number and kind of animals.

4. The water heretofore used for Quasi-Municipal and Domestic If for stock state number and kind of animals.

5. The water is to be diverted at the following point SE 1/4 NE 1/4 Section 30, T21N, R18E, M.D.B. & M., or at a point from which the Northeast corner of said Section 30 bears N 35° 07' 55" E 1,713.0 feet stated.

6. The existing point of diversion is located within NE 1/4 NE 1/4 Section 21, T21N, R18E, M.D.B. & M., or at a point from which the Northwest corner of said Section 21 bears N 72° 48' 50" W 4,260.0 feet If point of diversion is not changed, do not answer.

7. Proposed place of use Portions of the E 1/2 NE 1/4 and portions of the E 1/2 SE 1/4 Section 30, portions of the W 1/2 NW 1/4, portions of the SW 1/4 Section 29 lying East of Nevada-California Stateline all in T21N, R18E, M.D.B. & M. Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.

8. Existing place of use SW 1/4, S 1/2 SE 1/4 Section 16, NE 1/4 Section 20, N 1/2 NW 1/4, portions SW 1/4 NW 1/4, SE 1/4 NW 1/4, portions of NE 1/4 SW 1/4, NE 1/4, N 1/2 SE 1/4, SE 1/4 SE 1/4, portions of SW 1/4 SE 1/4 all in Section 21, all in T21N, R18E, M.D.B. & M. Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.

9. Use will be from January 1 to December 31 of each year. Day and Month Day and Month

10. Use has been from January 1 to December 31 of each year. Day and Month Day and Month

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drill well, install pump and motor, construct water transmission lines and domestic water storage tank. This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 26957 is issued subject to the terms and conditions imposed in said Permit 26957 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under this permit and Permits 26956, 26957, 26958, 29459 and 29461 shall not exceed 707.55 million gallons annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed.....0.5.....cubic feet per second but not to exceed.....117.9 million gallons annually.....
