The applicant Western Horizon Lands Corp. c/o Cortland E. Nielsen P. O. Box 1012, of Winnemucca, Nevada 89445, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

6. Place of use NW 1/4 SW 1/4 Section 5, T.39N., R.39E., MDB&M Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Day and Month Day and Month

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A substantial weir or other type of measuring device must be installed and measurements of water use kept. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.8 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before March 24, 1977
- Proof of commencement of work shall be filed before April 24, 1977
- Work must be prosecuted with reasonable diligence and be completed on or before March 24, 1978
- Proof of completion of work shall be filed before April 24, 1978
- Application of water to beneficial use shall be made on or before March 24, 1979
- Proof of the application of water to beneficial use shall be filed on or before April 24, 1979
- Map in support of proof of beneficial use shall be filed on or before April 24, 1979
