

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant WINE GLASS, INC. of Round Mountain Nevada 89045 hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is underground Name of stream, lake or other source.

2. The amount of water applied for is 3.0 second-foot One second-foot equals 448.83 gals. per min.

Place of use N.E. 1/4, N.W. 1/4, N. 1/2 of S.E. 1/4, N.E. 1/4 of S.W. 1/4, N.W. 1/4 of S.W. 1/4, S.W. 1/4 of S.W. 1/4 of Section 20, T.11N., R.43E., M.D.M., E. 1/2 of S.E. 1/4, E. 1/2 of N.E. 1/4 of Section 19, T.11N., R.43E., M.D.M.; excepting therefrom the following: Commencing at the S.W. corner of S.E. 1/4 of the S.E. 1/4, Section 18, T.11N., R.43E., E. 3960', S.E. corner S.W. 1/4, Section 17, S.550' to fence line, N.87°20'W., 3964' along fence line, N. 365' to S.W. corner of S.E. 1/4 of S.E. 1/4 Section 18, T.11N., R.43E., M.D.B.M., Point of beginning; part and parcel of land as situated in N. 1/2 of N. E. 1/4 of N.E. 1/4 Section 19, situated in N. 1/2 of N.W. 1/4 Section 20, T.11N., R.43E., M.D.B.M., containing 41.59 acres.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, cased, pump and motor with irrigation through pipes and ditches

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. If it is also understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is issued subject to the terms and conditions of State Engineer's Ruling No. 2198 dated March 7, 1977.


The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.0 cubic feet per second but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before..... October 4, 1977
- Proof of commencement of work shall be filed before..... November 4, 1977
- Work must be prosecuted with reasonable diligence and be completed on or before..... October 4, 1978
- Proof of completion of work shall be filed before..... November 4, 1978
- Application of water to beneficial use shall be made on or before..... October 4, 1981
- Proof of the application of water to beneficial use shall be filed on or before..... November 4, 1981
- Map in support of proof of beneficial use shall be filed on or before..... November 4, 1981
