of water heretofore appropriated under permit No. 28187, Cert. 8544

1. The source of water is underground. Name of stream, lake or other source.

2. The amount of water to be changed -5-4-EFS- 3.7 (W.R.) Second feet, acre feet.

3. The water to be used for irrigation and domestic. If for stock state number and kind of animals.

4. The water heretofore used for irrigation and domestic. If for stock state number and kind of animals.

5. The water is to be diverted at the following point in the NE 1/4 SW 1/4 section 4, T.43N., R.31E., M.D.B. & M., from which the West one quarter corner of said section 4 bears N. 63° 52' 10" W., 2965 feet.

6. The existing point of diversion is located within. If point of diversion is not changed, do not answer.

7. Proposed place of use. S 1/2 Sec. 21, S 1/2 Sec. 22, S 1/2 Sec. 27, N 1/2 Sec. 28, S 1/2 Sec. 28, N 1/2 Sec. 33, S 1/2 Sec. 33, N 1/2 Sec. 34, T.44N., R.31E., and N 1/2 Sec. 3, S 1/2 Sec. 3, N 1/2 Sec. 4, S 1/2 Sec. 4, T.43N., R. 31E., M.D.B. & M., 3818 acres.

8. Existing place of use. S 1/2 section 4, T.43N., R.31E., M.D.B. & M., 316 acres.

9. Use will be from January 1st to December 31st of each year.

10. Use has been from January 1st to December 31st of each year.

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Well, pump, pipelines and sprinklers.

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 28187, Certificate 8544 is issued subject to the terms and conditions imposed in said Permit 28187, Certificate 8544 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The total annual duty under this permit shall not exceed 1264.0 acre feet.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.7 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

- Actual construction work shall begin on or before September 26, 1976
- Proof of commencement of work shall be filed before October 26, 1976
- Work must be prosecuted with reasonable diligence and be completed on or before September 26, 1976
- Proof of completion of work shall be filed before October 26, 1976
- Application of water to beneficial use shall be made on or before September 26, 1979
- Proof of the application of water to beneficial use shall be filed on or before October 26, 1979
- Map in support of proof of beneficial use shall be filed on or before October 26, 1979
